- Received a \$10,000 grant from Missouri State Library to buy books. Not a targeted grant. Given to libraries that didn't receive state aid. Children's

- and Teen will receive a large part of the grant, with Adult receiving the remainder.
- Opening in page department. Kolourz Voss resigned due to relocation.
- May 12 is ribbon cutting for Family Place Libraries. Inspection for our national designation will be then as well. Board members are encouraged to attend the ribbon cutting.
- For FY16, state aid has not been returned to budget, but REAL funding has. Portion added to the bill in committee didn't make it through.
- Discussion about relationship between the Post Art Library and JPL, and the possibility of integrating Post into JPL. The two Boards would have to work together to create a memorandum of understanding if this occurs.
- Will probably be gone Friday-Monday. Uncle passed away and she will need to drive her mother to Iowa.
